### Description

The CPC1017N is a miniature single pole, normally open (1-Form-A) solid state relay in a 4-lead SOP package that employs optically coupled MOSFET technology to provide  $1500V_{rms}$  of input/output isolation. The super-efficient MOSFET switches and photovoltaic die use IXYS Integrated Circuits Division's patented OptoMOS architecture while the optically coupled output is controlled by a highly efficient GaAIAs infrared LED.

IXYS Integrated Circuits Division's state of the art double-molded vertical construction packaging enables CPC1017N to be one of the world's smallest relays. It offers board space savings of at least 20% over the competitor's larger 4-lead SOP relay.







**Typical Blocking Voltage Distribution** (N=50, T\_=25°C)



#### **Moisture Sensitivity**


#### **Board Wash**

IXYS Integrated Circuits Division recommends the use of no-clean flux formulations. However, board washing to remove flux residue is acceptable. Since IXYS Integrated Circuits Division employs the use of silicone coating as an optical waveguide in many of its optically isolated products, the use of a short drying bake could be necessary if a wash is used after solder reflow processes. Chlorine- or Fluorine-based solvents or fluxes should not be used. Cleaning methods that employ ultrasonic energy should not be used.


